1. All applicants are required to submit with the application an approved Certificate of Stock and check for Transfer Fee, a check for Initiation Fee, or a check for Stock Purchase.
2. Dues and assessments for the year are assessed for the entire year on July 1st of each year. Dues and assessments are paid by monthly installments in advance.
3. All accounts are payable 30 days from due date. The Club rules provide that delinquent account be posted 45 days from due date and members so delinquent are subject to suspension at the end of 60 days.
4. All applications for membership must be received in time by the Membership Committee to permit a 10-day posting prior to the Board of Directors' Monthly Meeting (usually the third Wednesday of each month).
5. Rules on Changes and Resignations: "No member can reduce or resign his membership except with a 30 day notice prior to the first day of the Membership Year, which is July 1st of each year." All applications to resign or change type of membership must be in writing.

This application made subject to the approval of the Board of Directors, and if elected to membership, I shall be governed by the By-Laws of the Club and such rules and regulation as the Board may, from time to time, promulgate.

Membership Classes

Full Family Membership:

This class is for members who are married, with or without children or single with children. This class entitles you and your family members to full use of the facilities. Children who are under age 18, or less than 25 years of age and attending college while residing principally at home qualify as members. Grand children are always welcome as members.

Full Single Membership:

This class is for members who are single and who have no children who qualify as members. This class entitles you to full use of the facilities.

Social Membership:

This class is for members, married or single, with or without children. This class entitles you to full use of the clubhouse. Members in this class may play golf, tennis or swim five times annually by paying the usual green fee or guest fee.

Family Social-Swim-Tennis

This class is for members with or without children or single with children. This class entitles you to full use of the clubhouse, swimming pool and tennis courts. Members in this class may play golf five times annually by paying the usual green fees or guest fees.

Single Social-Swim-Tennis

This class is for members who are single and who have no children who qualify as members. This class enjoys the same privileges as the family social-swim-tennis.

Junior Family Membership:

This class is for members who are under the age of 35, married, with or without children or single with children. This class enjoys the same privileges as the full family membership class.

Junior Single Membership:

This class is for members who are under age 35, single and who have no children who would qualify as members. This class enjoys the same privileges as the full single membership class.

Non-Resident Membership:

This class is for members of any age, single, married or single with children. Members in this class must live at least 35 miles from Beckley and not maintain a residence in Raleigh County. Members in this class enjoy full use of the facilities.
